1. CNIC POM-15 data collection and analysis is under way. Dynamic discussions with Resource Sponsor OPNAV N-4 are being held and a general timeline (subject to change depending on new guidance from OPNAV) for POM-15 is below;

2. Initiatives and Vignettes:

- The capture and update of Initiatives and Vignettes will be an ongoing process.
- Initiatives are defined as significant additions/deletions to Requirement such as a change of Homeport, or Fact of Life type changes to Requirement such as a utility rate increase.
- ➤ Headquarters Program Directors (HPDs) will be able to create Initiatives and Vignettes in the Price Performance Enterprise Model (PPEM) PREP Tool for Regions to populate data.
- Additionally, Regions may coordinate with HPDs and identify Initiatives they would like the HPDs to create in the PPEM PREP Tool.
- We expect no more than a three day turnaround time by the HPDs to create the Initiative in the PPEM PREP Tool once the Regions identify such Initiatives.
- ➤ Regions will have until 06 July to populate data to validated Initiatives/Vignettes in the PPEM PREP Tool but any Initiative they wish to have entered in the PREP Tool must be coordinated with the respective HPD by 22 June.
- ➤ Regions may use the 25 June 06 July period to conduct Regional Murder Boards.
- 3. HPDs will build the EVR in the TM1 module of the PPEM PREP Suite of Tools. HPDs will then be able to use the PPEM PREP Tool to create Program Stackers. The EVR, Program Stackers, and Murder Board slides will be complete prior to the commencement of HQ Murder Board/Leadership approval process 23 July.
